Specificity

Rabbit anti Bovine osteocalcin antibody recognizes the carboxy-terminal region of osteocalcin, also known as bone gla protein, BGP or Gamma-carboxyglutamic acid-containing protein.

Osteocalcin is a 49 amino acid protein secreted by osteoblasts from a precursor protein with an additional 28 amino acid propeptide together with a 23 amino acid signal peptide. Osteocalcin

serves as a useful biomarker for bone formation.

Storage Store at +4°C or at -20°C if preferred.

Storage in frost-free freezers is not recommended.

This product should be stored undiluted.

Avoid repeated freezing and thawing as this may denature the antibody.

Should this product contain a precipitate we recommend microcentrifugation before use.

Shelf Life 18 months from date of despatch.
