Mouse anti Testosterone antibody, clone BGN/3G8A4 also recognizes 5-a-Dihydrotestosterone

(1%) and Androstenedione (1%).

**Storage** Store at +4°C or at -20°C if preferred.

Storage in frost-free freezers is not recommended.

This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before

use.
