Reconstitution	Reconstitute with 0.1 ml distilled water. Care should be taken during reconstitution as the protein may appear as a film at the bottom of the vial. Bio-Rad recommend that the vial is gently mixed after reconstitution.

Antiserum Preparation Antisera to mouse MCP-3 were raised by repeated immunisations of goats with highly purified antigen. Purified IgG was prepared from whole serum by affinity chromatography.

Specificity	Goat anti Mouse MCP-3 antibody recognizes mouse monocyte chemoattractant protein 3 (MCP-3), also known as CCL7.
	MCP-3 is chemotactic for monocytes, lymphocytes, eosinophils and basophils and is reported to be involved in allergen induced inflammation.
Storage	Prior to reconstitution store at +4°C. Following reconstitution store at -20°C.
	This product should be stored undiluted.
	Storage in frost-free freezers is not recommended. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use. For long term storage, the addition of 0.09% sodium azide is recommended.
	N.B. For functional studies do not add azide.
