Fusion Partners	Spleen cells from immunized Balb/c mice were fused with cells from the Sp2/0 myeloma cell line.
Specificity	Mouse anti Human TSG101 antibody, clone 5B7 recognizes human Tumor susceptibility gene 101 protein, also known as TSG101 or ESCRT-I complex subunit TSG101. TSG101 is a 389 amino acid ~48 kDa regulator of the vesicular trafficking process, required for the completion of cytokinesis. TSG101 contains a single <u>UEV</u> domain required for ubiquitin interaction and a single <u>SB</u> domain.
Storage	Store at -20°C only. Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
Shelf Life	18 months from date of despatch.
